ALL FEES MUST BE PAID IN FULL PRIOR TO THE START OF TERM. FAILURE TO DO SO MAY RESULT IN AN ADMINISTRATION FEE BEING ADDED TO YOUR BALANCE.

2. LATE PAYMENT:

IF FEES REMAIN UNPAID AFTER THE TERM HAS BEGUN AND FOLLOWING SEVERAL EMAIL REMINDERS, A LATE PAYMENT FEE OF 2% PER WEEK WILL BE APPLIED TO THE OUTSTANDING BALANCE FOR EACH WEEK THE FEES **REMAIN UNPAID** 

3. MISSED SESSIONS AND REFUNDS:

### **EXPECTED COSTS AT CCTS**

AT CCTS, WE PRIDE OURSELVES ON KEEPING OUR TRAINING ACCESSIBLE AND AFFORDABLE. TO HELP PARENTS PLAN AHEAD, WE'VE OUTLINED THE EXPECTED COSTS ACROSS THE ACADEMIC YEAR:

TERM 1 – UNIFORM REQUIREMENTS
TO SUPPORT HIGH STANDARDS OF TECHNIQUE AND DISCIPLINE, APPROPRIATE
GROOMING AND CORRECT UNIFORM ARE ESSENTIAL IN ALL DANCE CLASSES.
ALL STUDENTS ARE REQUIRED TO WEAR THE OFFICIAL CCTS UNIFORM, WHICH
INCLUDES:

CCTS THEATRE SCHOOL T-SHIRT (COMPULSORY)
BLACK LEGGINGS, BLACK TRACKSUIT BOTTOMS OR JAZZ PANTS
BLACK JAZZ SHOES

UNIFORM ITEMS CAN BE ORDERED VIA OUR WEBSITE:

ORDERS CAN BE ARRANGED FOR COLLECTION OR DELIVERY. PLEASE NOTE THAT ONLY THE CCTS T-SHIRT IS A REQUIRED PURCHASE FROM US – OTHER ITEMS MAY BE SOURCED ELSEWHERE, PROVIDED THEY MEET THE REQUIREMENTS.

TERM 2 – SHOW FEE

A SHOW FEE OF £25 WILL BE CHARGED FOR THOSE PARTICIPATING IN OUR END-OF-TERM PRODUCTION.

THIS FEE COVERS VENUE HIRE AND ADDITIONAL STAFFING FOR REHEARSALS.
PARTICIPATION IN THE SHOW IS COMPLETELY OPTIONAL – CHILDREN ARE WELCOME TO CONTINUE ATTENDING REGULAR CLASSES EVEN IF THEY CHOOSE NOT TO PERFORM.

TERM 3 – COSTUME AND SHOW TICKET COSTS
COSTUME FEES WILL VARY DEPENDING ON THE PRODUCTION; HOWEVER, WE DO OUR
BEST TO KEEP THESE TO A MINIMUM.

IN MANY CASES, WE ASK PARENTS TO SUPPLY BASIC ITEMS FROM HOME, WHICH CAN ELIMINATE THE NEED FOR A COSTUME FEE ALTOGETHER.

WHERE COSTUMES ARE PROVIDED, THEY ARE YOURS TO KEEP AFTER THE SHOW.
SHOW TICKETS WILL BE AVAILABLE FOR PURCHASE CLOSER TO THE PERFORMANCE DATE,
WITH THE OPTION TO BUY A DIGITAL DOWNLOAD OF THE SHOW AS AN ADDITIONAL
EXTRA.
