Helping Parents understand Penalty Notice Fines for School Attendance

From 19 August 2024, there is a National Framework for Penalty Notice Fines being issued for unauthorised absences recorded by schools.

National Threshold

A single consistent national threshold for when a Penalty Notice **m<u>ust</u>** be considered by **ALL** schools in England, this is:

- 10 sessions (usually equivalent to 5 school days) of unauthorised absence within a rolling 10 school week
- period.
 - These sessions do not have to be consecutive and can be made up of a combination of any type of
- unauthorised absence.
- For example, a 5-day unauthorised leave of absence would meet the national threshold. The 10-school week period can span different terms or school years.

Who may be fined?

- Penalty Notice Fines are issued to each parent who allows their child to be absent without authorisation from school.
- <u>For example,</u> 3 siblings absent for unauthorised leave during term-time would result in each parent/carer receiving 3 separate fines.

Definition of Parent

- Section 576 of the Education Act 1996 states that, in relation to a child or young person, a 'parent' includes any
 person who is not a parent (from which can be inferred 'biological parent') but who has parental responsibility
 for or care of the child.
- Parent refers to a person who typically has care of a child or young person if the child lives with them either full or part time and they look after them, irrespective of what their biological or legal relationship is with the child.

First Offence

The first time a Penalty Notice is issued for unauthorised absence, the fine amount will be:

- £80 per parent, per child if paid within 21 days.
- If **not paid within 21 days**, the fine will increase to **£160 per parent, per child**, payable between the 22nd and 28th day.

Second Offence (within 3 years)

The second time a Penalty Notice is issued for unauthorised absence, a reduced rate is not available. The amount therefore yell ber parent, per child – payable within 28 days.

Third Offence and Any Further Offences (within 3 years)

The third time an offence is committed, a Penalty Notice WILL NOT be issued, and the case will be presented **straight to the Magistrate's Court:**

- Prosecution can result in criminal records and fines of up to £2,500. Cases found guilty in a Magistrates Court
- can show on the parent's future DBS (Disclosure and Barring Service) certificate (Disclosure and Barring Service) due to a 'failure to safeguard a child's education'

- 1. Registrations Yes, we will start accepting registrations as from 9th September 2024. Please email info@topkidzgroup.co.uk for registration information.
- 2. Price All this information is within the registration link. Until 5 pm £9; Until 6 pm £11. There will be opportunities for ad hoc bookings for an extra 10% please.
- 3. Siblings discount There is a 10% siblings' discount if they attend on the same days.
- 4. Take over date Provisionally set for week after October half term holidays.
- 5. Minimum required per day We require registered regular interest of 10 children per day to offer any day of the week.
- 6. Flexibility Due to current working patterns, we offer flexibility at all our settings. Having said that, we also need to ensure we stay financially viable and keep in line with Ofsted's regulations and standards at all times.
- 7. Activities on offer Further information on these can be found in our registration information. Also, please visit our website to give you an idea of what we do at our settings.
- 8. Payment Yes, we will accept childcare vouchers, Tax Free Childcare payments and Bank transfers.
- 9. Food provided We offer a substantial snack at all our settings, not dinner but something that will keep children until they get home at around 6/6.30 pm. Further details shared within the registration information.

Reception and Nursery - Google Classroom Access

Dear Parents,

At Hartsbourne, each class has their own Google Classroom. This is where we will share information, such as what children are learning in class, make any requests, for example for when children need to bring anything specific into school, and where we will give ideas for home learning, and for Reception, where we will set homework tasks.

To join your child's Google Classroom:

- go to: www.classroom.google.com (this can be done on any device)
- enter your child's email address (this can be found in your Arbor account)
- enter the password 'changeme' and you will be prompted to set a new password.

We would also recommend downloading the Google Classroom app as you can set this to alert you when your child's class teacher posts something new.

Year 4 - Swimming

In Autumn Term, Year 4 will have swimming lessons on Tuesday afternoons. The class is split into two groups with half having lessons before half term and the other half after half term. Girls are required to wear a one-piece swimming costume (i.e. not a bikini) and boys are required to wear swimming trunks rather than long swimming shorts. Girls with long hair must wear this tied back and jewellery must not be worn in the pool.

In order to cover costs for the minibus we do have to ask for a £5 voluntary contribution. This option has been added to Arbor for the **first group of children only** and so this will not be showing under trips for your child if they are due to have lessons after half term.
